Prospective New Patients Please Read

Thank you for your interest in becoming a new chiropractic patient with Dr. Darci!

Dr. Darci has been a licensed chiropractor for over 30 years. She now has reduced office hours and accepts a limited number of new patients on a case-by-case basis and ONLY for minor aches & pains and maintenance care.

Anyone who has multiple issues or complex issues or anything other than minor aches and pains should seek treatment elsewhere.

Your first chiropractic visit is about an hour, and the fee is \$325.

Payment is required prior to service.

There are no other fees for the first visit.

We accept all major credit/debit cards, cash, or checks.

Your visits at our office are not covered by any insurance or Medicare.

We do not offer any receipts suitable for self-filing.

Your first visit includes: a review of your history; an ortho-neuro exam; warm-up on a roller massage table if permitted by your condition; your chiropractic adjustment, and her recommendations for homecare.

As stated, Dr. Darci's specialty is minor aches & pains and maintenance care; therefore, we do not offer X-rays or any therapies such as electric muscle stim, ultrasound, etc.

After your first visit, our office visit fees are \$89 for a 15-minute visit; however, there are discounts for frequency within the same calendar month. For example, after your first visit as a new patient, your visits are reduced to \$69 for the rest of the calendar month.

Going forward, there are also frequency discounts for consecutive months: if you have at least 2 visits during the prior calendar month, all your visits during the current calendar month are at \$69 each. If you have one visit during the prior calendar month, your next visit during the current month is \$79, and then \$69 for all visits during the remainder of the month. If you had no visits during the prior calendar month, your next visit will be \$89, then \$79, then \$69 for the current calendar month.

During the busy season, there will likely be an initial delay in your follow-up visits after your first visit. We typically have waiting-list-only availability for established patients for several weeks. After-hours appointments which bypass the waiting list are available at a much higher fee: these are the only quick access (short-notice) appointments that are usually available for established patients. Most established patients schedule their appointments weeks and months in advance.

established patients.

If you are ever in an accident in which insurance may be involved, you will be referred to another chiropractor until you are released from that accident

treatment.
